Government Developments

December 15th, 2017

- The House of Commons and the Senate have now adjourned for the Christmas break. The House will resume sitting on January 29 and the Senate on January 30.
- Bill 161, *An Act to amend the Act respecting the conservation and development of wildlife*, remains at First Reading in the National Assembly of Quebec. This Bill grants wildlife protection officers new powers; prohibits using an aircraft for hunting activities, including to locate or drive animals; regulates the possession, sale and purchase of animal by-products; requires the Minister to develop and implement programs to restore or create wildlife habitats; and gives the Minister the power to authorize the implementation of pilot projects concerning the protection or development of wildlife. - On December 8, British Columbia Minister of Forests, Lands, Natural Resource Operations and Rural Development made a statement regarding the grizzly bear hunt. He noted that approximately 4,200 written responses were received during the public engagement period and that the Government will be releasing a consultation report including any new policy direction in

- On December 11, the Atlantic Premiers issued a joint release on the outcome of the 32nd meeting of
 the Council of Atlantic Premiers in Halifax. Of interest, the Premiers expressed their support for a

- On December 13, Fisheries Minister Dominic LeBlanc signed eight Critical Habitat Orders under the *Species at Risk Act*. The approved orders will allow for further protection of eight at-risk species, including: two whales, three fish species, Rocky Mountain Sulpin, and one mollusc species. A Critical Habitat Order prohibits human activities that may destroy the defined critical habitat of an at-risk species. December 1st, 2017

- During a reception for the Committee on the Status of Endangered Wildlife in Canada (COSEWIC), the Government of Canada committed to a targeted timeline for making decisions to list species under the *Species at Risk Act*, following COSEWIC's submission of its assessment to the Minister of Environment and Climate Change. The timeline would be 24 months for terrestrial species and some aquatic species, and 36 months for more complex aquatic species such as actively fished species. - In the November 29 edition of the Quebec Gazette, the Province posted a draft regulation entitled An Act respecting the conservation and development of wildlife (chapter C-61.1) regarding the Scale of fees and duties related to the development of wildlife. The draft regulation eliminates the duties payable for the issue of caribou hunting licences provided for in Schedule I to the regulation respecting the scale of fees and duties related to the development of wildlife. The draft regulation also amends section 4.1 of the regulation to specify that sport fishing licenses for Atlantic salmon issued for a day will be issued for three days.
